Letter of Inducement for PBS 329, LLC. Mr. Jim Woodward of Gray Pannell & Woodward LLP, Mr. Bobby Patel of Nexera Capital, and Mr. Sam Patel of Emerge Hospitality Group appeared in connection with the request to approve a letter of inducement for the issuance of up to \$53,669,949 in taxable revenue bonds to finance the acquisition and construction of a hotel project that would include approximately 10 stories, 183 rooms and three food and beverage outlets to be located at 329 Marietta Street N.W. in the City of Atlanta. Upon a motion made by Vice Chairman Hall, which was seconded by Ms. Long, the Authority approved the letter of inducement for PBS 329, LLC, with the exception of Dr. Looney and Mayor Bodker who voted no.
